#### TSG moving from ideas to action

from last Governing Board meeting on 20-21 February 2019 (15 minutes):

#### Key achievements and main outcomes

Organisation of two TSG 3: 1. by Croatia in Zagreb, March 2019 were organized and 2. by Sarajevo in Bosnia and Herzegovina, November 2019.

•Create a list of TSG 3 priorities was agreed and sent to the presidency on 15 April 2019.

• Two cross-pillar projects ideas: TSG 3/1 on MSP/ICZM and TSG 3/4 "Managing Tourism Flows in Protected Areas" (ADRIONet) were submitted under open call FP+ and administratively approved on 13 August 2019.

• Active participation of TSG 3 at the 4<sup>th</sup> EUSAIR Forum in Budva, 6-7 May 2019 with organisation of the Pillar Session B: Marine Spatial Planning (MSP) as Cross-Cutting Theme of the TSGs of the EUSAIR.

•Active participation of TSG 3 members at the **Mediterranean Coastal and EU Macro-regional Strategies Week 2019**, In particular for the development of the mono-pillar project concepts was very important
