 (already in the current one, but more probably in the next Programming period)

Thanks to the cooperation with the ESPON Programme, the difficulties in collecting data (especially for IPA countries) are being tackled => once the ESPON work is completed (in spring 2020) it will be possible to check and compare data and indicators for all the Macro-regional strategies on the online Territorial Monitoring Tool.
