Item 4 - Follow-up of the Catania Declaration

- **Governing Board members agreed to implement the Discussion paper** (from now on Position Paper) on implementation of Paragraph 6 of Catania Declaration in accordance with its new version (small changes, which mainly related to timing, were done), which was circulated after the GB meeting.
- It was agreed that TSGs members will propose their macro-regional priorities by the 15 April 2019, in the template that was prepared and circulated by the Facility Point Lead Partner (together with the new version of Position paper and the Roadmap).
- Support should be seeked in FP PPs as well as in National Coordinators for EU Funds.
- After the proposal of all TSGs, National Coordinators will consider and agree on proposed list, before the 4th EUSAIR Forum or by the end of May 2019 at the latest, but after prior consultation with national (relevant) authorities in their countries.





ALIGNMENT OF FUNDING FOR EUSAIR Roadmap proposal, FP LP, NC meeting, 20.2.2019

The document represents an overview of tasks, roles & responsibilities and relations in the process through the phases in terms of alignment of funding based on Discussion Paper prepared by EC and steps agreed among the EUSAIR National Coordinators. It is a vivid document and each step might be further elaborated.

Item 3 - Reports from the TSG and other meetings

- FP PPs supporting each Pillar have to be present at the respective TSG meetings and other events supporting the Pillar processes in the foreseen way. FP LP will still be present at all TSG meetings but with less active role to allow more active participation to the FP PPs and by this enable the development of a close relationship between the FP PPs and TSGs.
- **Reaching quorum at the some TSG meetings is still an issue.** When sending out invites to the meetings, it is necessary from now on to inform also NCs and FP PPs for their support in reassuring the presence of their national members at the meetings.
- Key outputs of the TSG meetings and other events should be sent also to the FP partnership, especially if there is an agreement on further steps that needs to be processed at national level.



Item 4 – WP T.1: Modus Operandi

Description of the FP's support to the TSGs in a simplified way, the ways of cooperation, including our roles and responsibilities in that respect. It is meant for all of us to commonly understand how we can cooperate and to what extent.

- The partnership developed the document Modus Operandi and commit to its implementation. However the document will be further developed on on-going basis.
- FP PPs may adopt the Modus Operandi for their needs at national level or for the needs of the Pillar to assure transparency of the processes and knowledge transfer as well.

Item 5 – Financial dialogues meetings

• Financial dialogues at national and macro-regional level are needed (and foreseen in the Application Form) to be organised on regular basis and in cooperation with TSGs and NCs. Good practice examples among the partnership could be shared.
