# NAMIRS project – North Adriatic Maritime Incident Response System

## APPROVED

- first project that is based on EUSAIR Flagship to received EU funding (European funding from the Union Civil Protection Mechanism)
- Project is based on EUSAIR TSG3 flagship – ASOSCoP, contingency plan in the event of accidents at sea in EUSAIR
- Aim: enhancing prevention of, and protection from, the effects of maritime disasters in the North Adriatic Sea
- Geographical scope: North Adriatic

# LIFE – NOAH – Northern Adriatic Open Habitats and Species - PROPOSAL

**The main project objective** is to mitigate the risk to these species through the analysis of their current status, their vulnerability and the ongoing and future threats in the region. This project specifically seeks to move beyond the 2D presence-absence information currently available to include the understanding of the **3D use of the offshore habitat by these three species.**

By collecting new and relevant data through dedicated surveys and analysis, including biologging sensors and tracking technologies, this project will **contribute to the understanding of environmental changes threatening of bottlenose dolphins, loggerhead turtles and European shags.**

In addition, the project will inform existing N2K sites, enhance management capacities, provide opportunities for citizen science engagement and contribute to the justification for **the extension of the N2K network into offshore areas.**
