

TSG moving from ideas to action - **Cooperation**

- Promoting Eco-Conectivity creating new Blue and Green Corridors in Western Balkan countries (Sava, Drina, Vardar rivers and Ohrid and Skadar lakes) - Sub regional cooperation in the Danube basin and Sava basin between EUSAIR, EUSDR, Western Balkan and Economic Investment Plan and with cooperation with the International Sava River Basin Commission (ISRBC)
- Reach Good Environmental status protected area to be able to use Ecosystem Services on efficient way in non EU Countries.

 (river basin, flood risk, sediment, climate adaptation, contingency)
- Integrated systems
 (information, forecasting, warning)
- Economic activities
 (navigation, river tourism, ...)
- Policy (protocols, policies / guidelines, harmonization)









TSG moving from ideas to action - Facility point contribution

- Engaged Innovation expert that will provide support to the process of aligning work of TSG3 and EUSAIR Facility Point project in the field of innovation focusing on topic of environmental quality (Topic 1 The marine environment or Topic 2 Transnational terrestrial habitats and biodiversity) in the field of eco-innovations and circular economy.
- Defining TSG3 priorities to Flagships Drafting the links between national priorities of all TSG
 3 member countries and priorities of EUSAIR Macro region
- Peparation of the project proposal 3MPS Application to LIFE programme Call 2021-2024. The call is oppened until 30.11.2021
