Dear TSG 1 coordinators.

Following the conclusions of the Governing Board (GB) regarding the embedding process, TSG 3 members within TSG 3 meeting (4-5 March 2020, Belgrade, Serbia) identify the possibility of a joint inter-pillar flagship with TSG 1 by combining TSG 3 priority MSP/ICZM with TSG 1 priorities.

**In this regard TSG 3 would like to officially invite and propose TSG 1 to join in the preparation of an inter-pillar flagship combining TSG 3 priority:** Promotion of sustainable growth of the AI region by implementing ICZM and Maritime Spatial Planning (MSP) also to contribute CRF on ICZM of Barcelona convention and the monitoring and management of marine protected area **with TSG 1 priority(ies).**
