# 1. PROLONGATION OF THE EUSAIR FACILITY POINT PROJECT

- ADRION Monitoring Committee approved the request to prolong the project until the end of August 2023.



## 2. CROSS-PILLAR PROJECT IDEAS

- EC did not prolong the Facility Point Plus project (FPP) – letter received in the beginning of January 2022.
- FPP management requested FP to search for possibilities to develop already defined, submitted and positively passed eligibility check the cross-pillar project ideas within the EUSAIR FP project.
- Meeting with Adrion Joint Secretariat took place -> need for adjustment of the WP T.2 Background document.

  - 1<sup>st</sup> INNO meeting in Autumn 2020 – meeting among S3 departments,
  - 2<sup>nd</sup> INNO meeting/workshop on innovation around the flagships (9.11.2021),
  - 3<sup>rd</sup> INNO workshop about innovations and innovativeness in the field of environment protection (also in relation to tourism) –April 2022. We will start the workshop with presentation of implemented activities and their results, as well as on various innovations (both technological and non-technological) that can significantly contribute to improving various challenges in the field of environment protection.
