ANALYSING: SYSTEM THINKING [16TH OF JULY 2021]

- Common understanding of the flagship
- Exchange of good practice on how to deal with flagship in the OP.
- Identification of best suitable SOs per flagship (synthesis table)



PLANNING: STRATEGIC THINKING [1ST OCTOBER 2021]

- Mapping ETC actions related to the flagships;
- Identification of nodes of complementarities between ETC programmes



IMAGINING: CREATIVE THINKING [19 NOVEMBER 2021]

Going from complementarities to synergies:

- Agreement on “pilot chain of projects” per flagships
- Agreement on a road map

COMMON UNDERSTANDING OF THE FLAGSHIP

PILLAR 2 – FLAGSHIP 2.1: SMART/GREEN PORTS HUB CONCEPT

Port network crossing along all EUSAIR countries and including all the ports belonging to the core and comprehensive network of the TEN-T Corridors involved

ZERO EMISSIONS IN PORTS

Infrastructure; ports as energy hub (including cold ironing; hybrid ships)

DIGITALISATION OF THE SUPPLY CHAIN

The use of smart digital solutions to optimize traffic flows and cargo handling in/ around ports; ICT to exchange real time information and data

PORTS AND CIRCULAR ECONOMY

In view of achieving the zero pollution goal, Ports have a role to play also as hub of circular economy (for collecting, transshipping and disposing of waste from ships and other port industries, and for decommissioning ships)

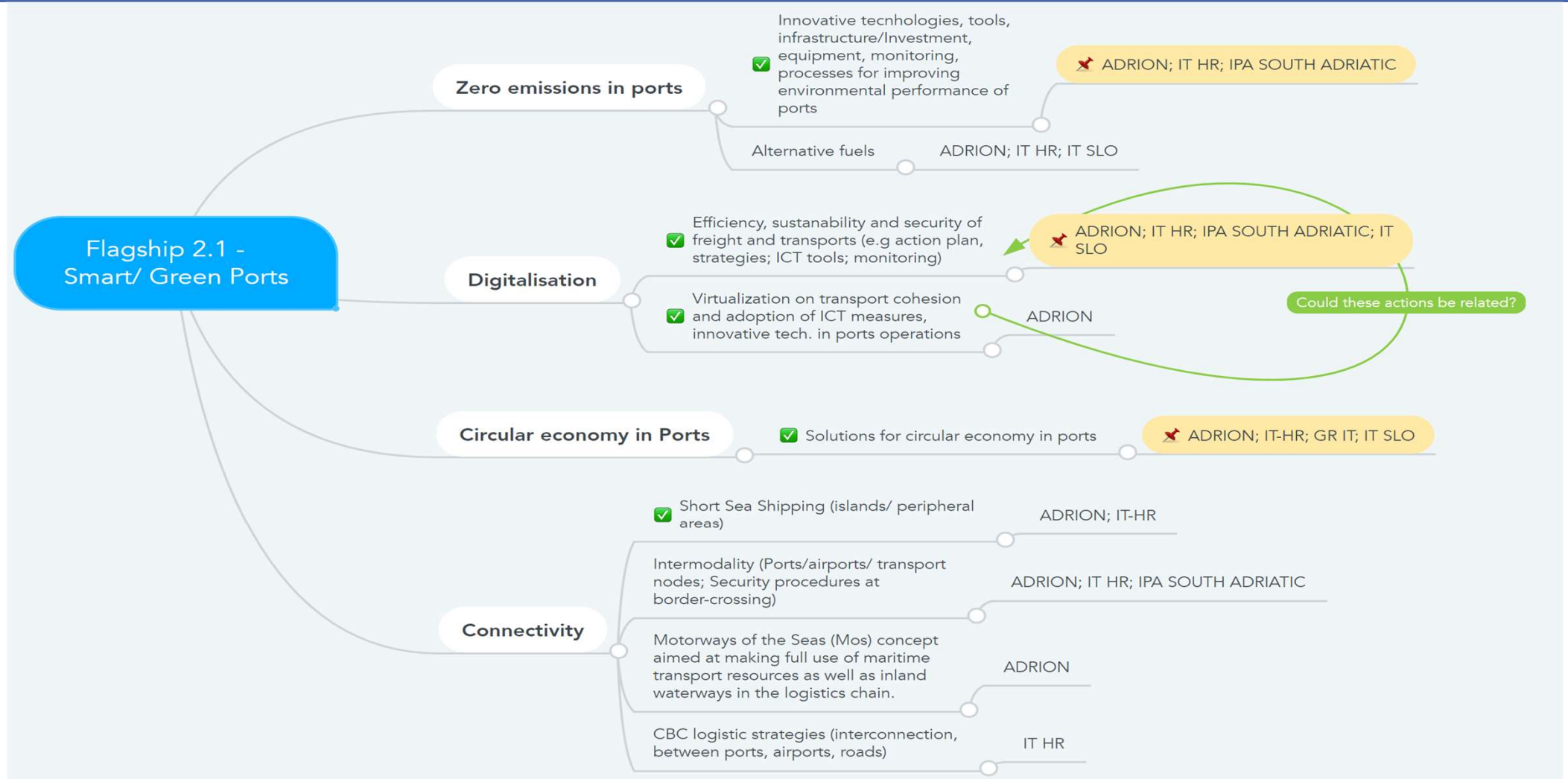
CONNECTIVITY

Mapping of local and macro regional needs and development of network of ports; boosting short sea shipping green solutions

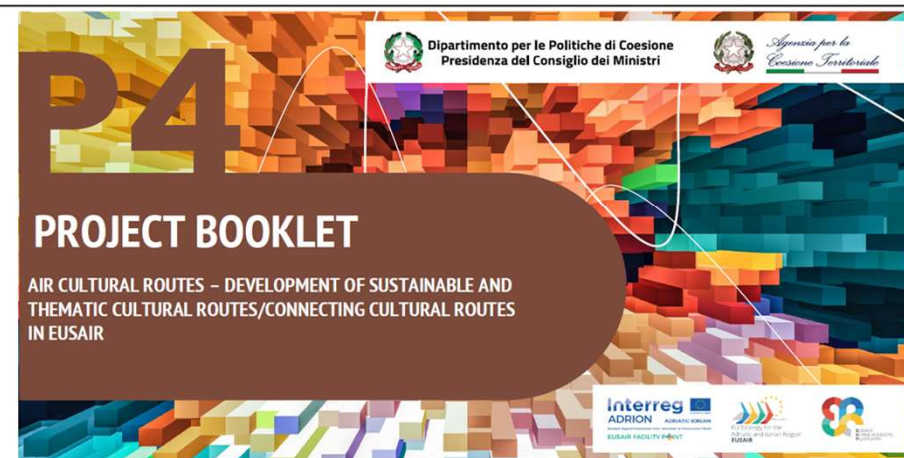
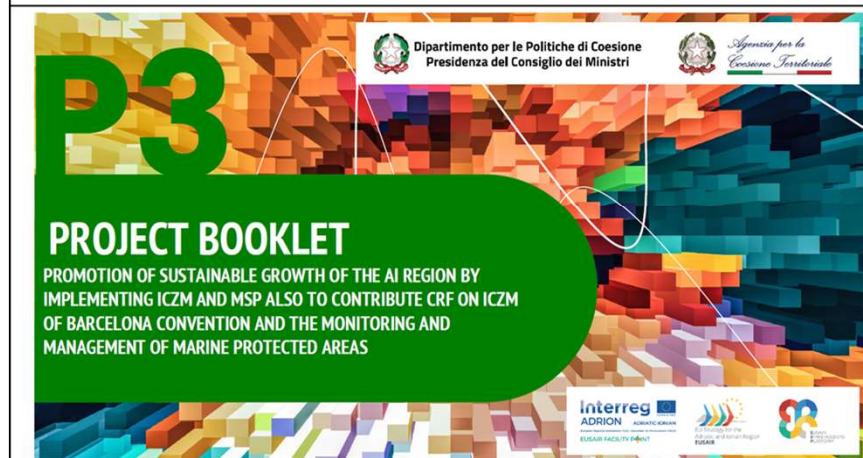
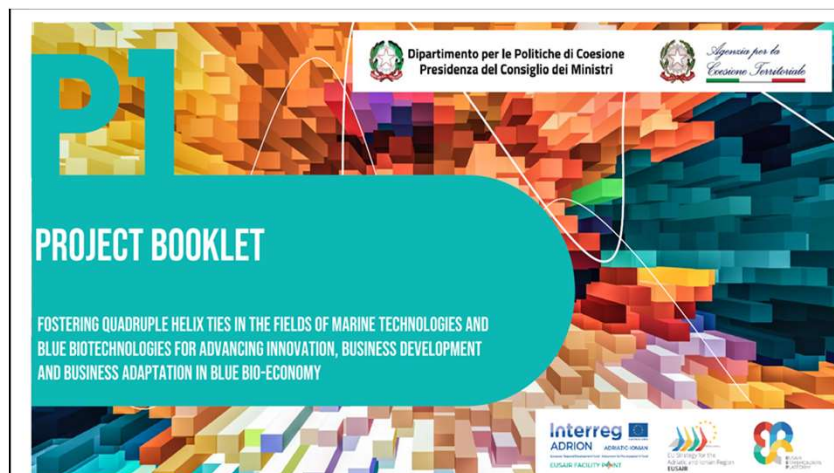
III ACTION LAB : NOW, WHAT?...WHAT ACTIONS PAVE THE WAY FOR HIGH LEVEL OF SYNERGIES?

2.1	<p>Digitalisation (ICT) in ports, with a main focus on information sharing along the logistic chain: just in time traffic management (maritime side) and real time information (land side).</p> <p>Other possible issues: safety at sea, cybersecurity; availability of basic infrastructure (e.g. 5/6 G even though it is more relevant for the larger ports).</p>	<p><i>ADRION; IT-HR; IPA South ADRIATIC; Greece-Italy; IT-SLO</i></p>	<p><i>Environmental performance of ports</i> (mainly green transport solutions/eco-friendly transports in ports, multi-modality between ports and hinterlands)</p>	<p><i>ADRION; IT-HR; IPA South ADRIATIC; Greece-Italy</i></p>
			<p><i>Alternative fuel:</i> avoid to concentrate on projects dealing with one single alternative fuel. THE WAY FORWARD

- ***Action Labs***
 - Opportunity to have a clear mapping of the ETC contribution to flagship 2.1. in 2021-27
 - Opportunity to foster a better understanding of the flagship. The description of the flagship is very generic and need also to be adapted to different type of funding sources.
 - TSG experts had the opportunity to come into contact with ETC programmes (MAs/JS);
 - Pave the way for a more structured dialogue with ETC programmes in 2021-2027.
- ***The way forward***
 - ***Cross programme working group***: permanent; with period meetings; opened to MAs/JS.
 - **Technical groups on specific flagships**: for harmonisation of the objectives of the calls; of the selection criteria; ToRs.
 - **Inter-programme capitalisation** activities and tools

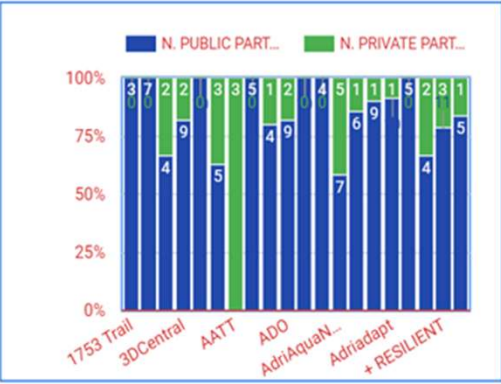
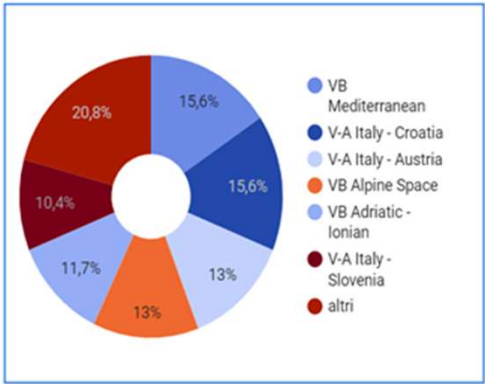

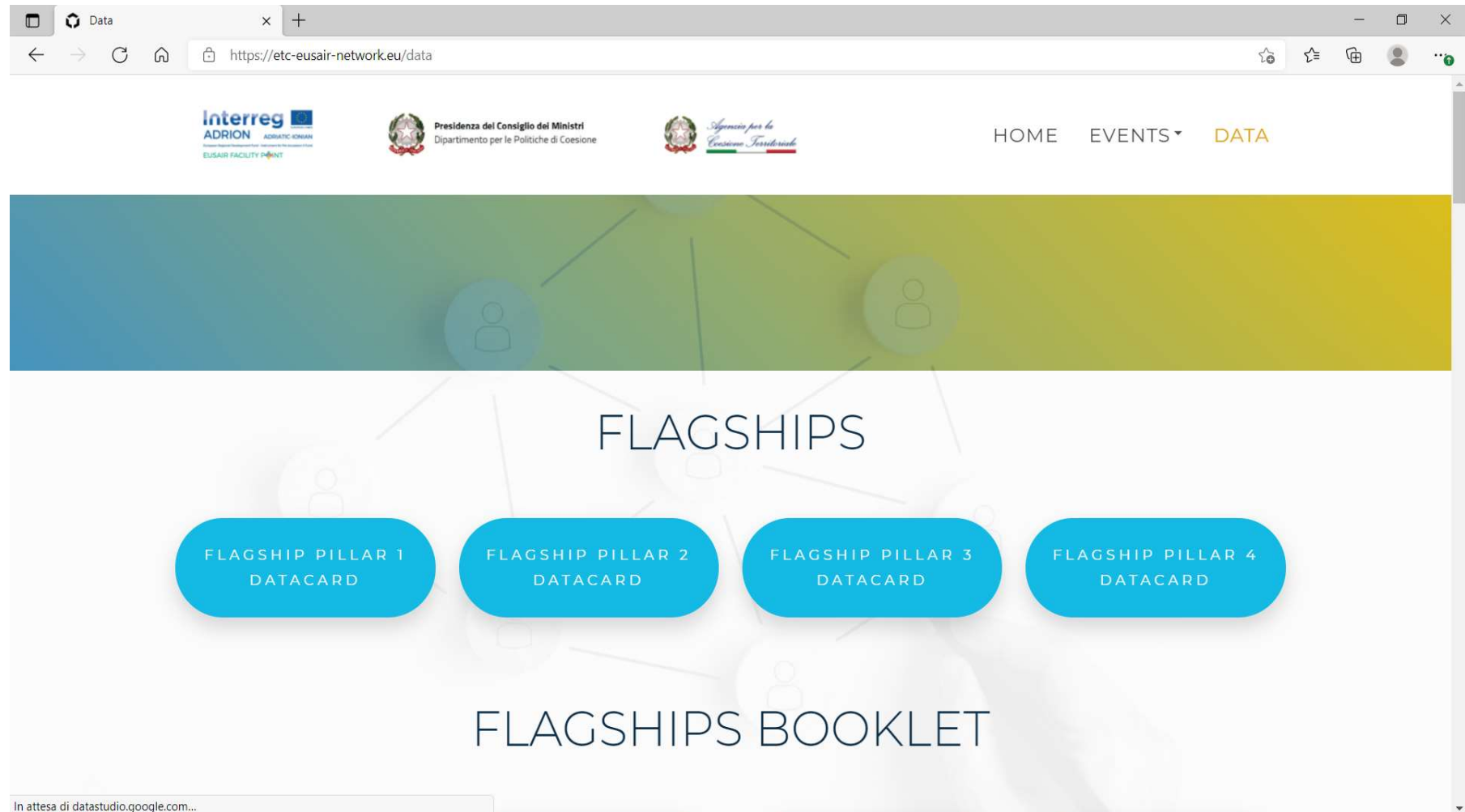
