Dear EUSAIR Governing Board members,

following the **Governing Board Written Procedure No. 2024/3** (launched on 9 April 2024) concerning **EUSAIR Revised Action Plan Pillar 2 Topic 2.4 Energy Networks and Topic 2.5 Green Energy as well as Pillar 3 Indicators**, comments were received within the deadline (16/04/2024) from Greece on indicators. The Presidency is acknowledging Greece's concerns regarding the set-up and monitoring of indicators of Pillar 2 Energy Topics and indicators of both Topics in Pillar 3 (as indicated in the attached document). After the GB Written procedure deadline further revisions were received from Greece on Pillar 2 Energy Topic Energy Networks (as indicated in the attached document). The Presidency appreciates the willingness for further improvements of the Action Plan input document, however because there is no more time left for further work and consolidation and after a positive exchange with Greek National Coordinators, the Presidency is closing the written procedure.

Documents of Pillar 2 Energy Topics and Pillar 3 indicators subject to approval by the written procedure No. 2024/3 are therefore considered approved, with Governing Board taking note of the comments and concerns raised by Greece.

Dear Eva, dear colleagues and friends from the Croatian Presidency,

With great disappointment and dissatisfaction I noticed the proposals for the changes on Pillars 2 and 3 regarding the indicators and other pending issues. It seems that what has been said and decided by the GB has not been taken into consideration by whoever prepared these documents.

Attached please find some comments so that you can get a grasp from what is really the case and what is at stake here.

My major concern is if the relevant TSGs and Pillar Coordinators (pillar 2-energy and 3) have approved this version of the action plan with the new inclusions. If so, we still cannot find a common understanding among the EUSAIR GB, TSGs and the EC, nor a way forward.

Please advice how we proceed. If I do not send these comments to the GB, will these documents be sent to the Commission and are we expecting the Commission to approve these documents attached so that we move on?

If these documents get approved, we will have serious issues with implementation and since Greece will lead the M&E package for the Strategy, it is evident, once again, that each pillar will follow a different methodology for monitoring and the basis for evaluation will not be even either.

Greece does not wish to block the procedures, but bear in mind that we won't be responsible for any problems arise with the monitoring and evaluation in the course of the years from the mess with indicators and the proposals inserted in the Revised Action Plan.

Eva, you were at the workshop of Interact on 4.4.2024 and you have taken down what the experts said about these issues.

Finally, is Baiba and Ilze Members of the EUSAIR GB (I saw them first in row in the recipients list)? Otherwise, they should not receive these documents under preparation phase, I believe.

Please advice because we are at a cross-road and we are running our of time.
