

## S4 S5: Main Characteristics:

- Stability of main structure Priority areas remain the same with more attention/visibility to Digital becoming now a separate priority(analysis & EDP)
- The <u>changes are more visible below</u> level of Priority areas – (i) Focus areas and technologies and Product lines and (ii) the role of horizontal network/Key Enabling Technologies (HOM/KETS) - significantly strengthened
- Stability in terms of Governance structure MLG – SRIP
- Stability and expansion (i.e. RRF) in terms of Policy mix measures and sources of financing

## Main Changes (at the latest stage):



- More coherent and overarching Logic of S5
- Omission of 3 main "baskets" (i) Digitalisation, (ii) Sustainable industries and services of the future, (iii) Quality of life
- Clear and understandable Main Goal Green transition
- Clear <u>"Enabling conditions"</u> for the goal: (i) with adequate Knowledge and skills, (ii) through empowered/more visible KETs (iii) on selected Priority domains (Focus areas / Product Groups)
- More visible <u>"horizontal"</u> topics of S5 (SBE, social innovation & other)

- Continuation & Reinforcement: variety of multilateral and bilateral cooperation (17 areas described in S5) among which also I3, Horizon, Vanguard, EIT, different MRS in particular EUSAIR, EUSALP, EUSDR, EuroMED; CBCs....bilateral focus cooperation including Joint interregional calls) – STourism BEING among them
